

**CERTIFICATE OF ASSOCIATION VOTE TO
FOREGO RETROFIT OF FIRE SPRINKLER SYSTEM
OF SEA COAST GARDENS II, A CONDOMINIUM**

This Certificate of Association Vote, to Forego Retrofit of Fire Sprinkler System of Sea Coast Gardens II, a Condominium, is recorded pursuant to Fla.Stat. §718.112(2)(1). This certifies that at a meeting of all voting interests in **SEA COAST MANAGEMENT NO. 2, INC.**, a not-for-profit Florida corporation, hereinafter referred to as "Association", on January 20, 2007, by an affirmative vote of two-thirds of all voting interests, the unit owners have voted to forego retrofitting a fire sprinkler system or other engineered life safety system in Sea Coast Gardens II, a condominium. The Association mailed, hand delivered, or electronically transmitted to each unit owner written notice at least fourteen days prior to the membership meeting conducted January 20, 2007. Notice of the results of the vote at that meeting were mailed, hand delivered or electronically transmitted to all unit owners within thirty days after the meeting. Compliance with the thirty day notice provision is by affidavit executed by the secretary of the Association and filed among the official records of the Association.
